SUBJECT: E-RATE UPDATE – APPLICATION WINDOW 11/5/01 THROUGH 1/17/02

The application window for Year 5 E-Rate funding of 2.25 billion dollars is now! After January 17, 2002, you will no longer be able to apply for funding that will be dispersed through June of 2003. In general, the E-Rate program stays the same for the 5th year of funding, however, there are some notable changes in items that are eligible for funding.

Year Four Funding Summary - (July 2001 through June 2002)

\$1.63 Billion of the possible \$2.25 billion has been awarded as of 10/30/01. This figure is the total through "wave 7" of funding. There were 23 waves in year three.

Year Four Highlights (to date):

- Over 80% of dollars went to the district level, instead of individual schools.
- Only the 90% discount band (i.e., where 75% or more of the students qualify for the school lunch program) received discounts on "Internal Connections".
- Urban schools received 2/3 of funding dollars (versus Rural schools).

Breakdown of Money Distribution:

- Telecommunications Services: \$665 Million.
- Internet Access: \$211 Million.
- Internal Connections: \$757 Million.

Year Five Funding - (July 2002 through June 2003)

Application Window: 11/5/01 through 1/17/01

Maximum annual funding allowed by law: \$2.25 Billion

Below is a table of Rauland-product related components and their respective status with E-Rate eligibility rules. The Schools and Libraries Division updated their rules at the end of October 2001, and this table reflects those changes. This is Rauland's interpretation of what is and is not qualified for e-rate funding. The ultimate decision on eligibility rests with Universal Services' Schools and Libraries Division.

E-rate (Education rate) is a Universal Service Fund created by the FCC Telecommunications Act of 1996. This act established a \$2.25 billion annual fund that is to be used to help schools and libraries pay for telephone and Internet access, as well as the internal connections that are needed. The money is supplied by telecommunications companies who are required to place a portion of their revenues into this fund. You may even notice this as an item on your monthly phone bill.
